<u>9 April 1945</u>: 1255 Q Underway from Navy Yard Philadelphia, Pa., for anti-aircraft firing off Cape May, N.J., in accordance with COTClant's dispatch 041532 of April 1945. 1817 Q Anchored in lower Delaware Bay.

10 April 1945: 1057 Q Underway for point X-ray - Roger, Delaware North Swept Channel for anti-aircraft firing practice. 1416 Q Exercised at streaming paravanes. 1635 Q Commenced compensating compasses. 1807 Q In anchoring in lower Delaware Bay, lost starboard stockless bower anchor plus one hundred twenty-five fathoms of chain.
